The distributions shall be made within two weeks of receipt of the signed order from the Court;
- The Commissioner is authorized to retain the sum of \$293,808 for payment of 3. administrative expenses incurred by the Commissioner for administrative and closing costs. The Commissioner is authorized to pay any excess closing and administrative costs out of the funds appropriated for the maintenance of the Department of Insurance. A report to the Court of the expenditure of these funds shall not be required;
