TO THE COURT, GOLDEN STATE MUTUAL LIFE INSURANCE COMPANY AND ALL INTERESTED PARTIES:

Applicant Steve Poizner, Insurance Commissioner of the State of California, in his capacity as Conservator ("Conservator") of Golden State Mutual Life Insurance Company in Conservation ("Golden State") hereby submits the following Status Report concerning the conservation of Golden State for the Status Conference hearing on January 12, 2011.

Service of this Status Report.

The Conservator hereby states that he has served copies of this Status Report to certain persons and entities known to the Conservator and his staff that may have a substantial, unsatisfied claim that may be affected by the Status Conference, regardless of whether the persons or entities are a party to this action or have appeared in it, in compliance with California Rules of Court Rule 3.1184(c). The certain persons and entities known to the Conservator and his staff to have a substantial, unsatisfied claim that will or may be affected by the Status Conference are identified on the Proof of Service attached hereto. Said persons are (1) Golden State's seven former Board of Directors; (2) the Pension Benefit Guaranty Corporation; (3) Golden State's home office landlord, Community Impact Development II, LLC; and (4) Golden State's 171 Certificate of Contribution contributors.

I. <u>UPDATE ON CONSERVATOR'S REHABILITATION PLAN AND ASSUMPTION</u> REINSURANCE AGREEMENT WITH IA AMERICAN LIFE INSURANCE COMPANY.

On September 2, 2010, the Conservator and IA American Life Insurance Company ("IA American") closed the Assumption Reinsurance Agreement dated May 7, 2010 and Agreement And Plan Of Rehabilitation For Golden State Mutual Life Insurance Company dated May 7, 2010, which were approved by this Court on June 24, 2010. The closing of these agreements means, in pertinent part, that (1) all of Golden State's in-force life, health and disability insurance policies and annuity contracts were transferred to and assumed by IA American, such that as of January 1, 2010, all rights, privileges, liabilities and obligations related to such policies and annuity contracts now belong to IA American, (2) all required governmental and state insurance

department approvals for the transaction were attained, (3) all assets to be transferred to IA

American were transferred including Golden State's mortgage loan portfolio, and (4) Golden

State received the required \$11 million ceding commission for the transaction, paid in the form of a credit to Golden State against transferred liabilities.

At this time, the Conservator understands that the transition to IA American of Golden State's former in-force life, health and disability insurance policies and annuity contracts, and all required policy documents and information, is substantially advanced and on track for completion.

II. CONSERVATOR'S MOTION FOR LIQUIDATION ORDERS.

On December 21, 2010, the Conservator filed and served a Motion for Order of Liquidation and Orders and Injunctions in Aid of Liquidation for Golden State Mutual Life Insurance Company ("Liquidation Motion"), seeking an order to liquidate and wind up Golden State's business, an order establishing a Claims Bar Date, and orders and injunctions in aid of liquidation. These orders are appropriate and required because, pursuant to Insurance Code § 1016, the Conservator has determined that it would be futile for him to proceed as Conservator since Golden State's estimated liabilities of \$9,291,895 exceed its estimated remaining assets of \$5,721,154 by over \$3 million (\$5,721,154 in assets - \$9,291,895 in liabilities = \$-3,570,741).

A hearing on the Liquidation Motion and an Order to Show Cause why the Court should not grant the Liquidation Motion, is scheduled for January 28, 2011, at 9:30 a.m. in this Court. Any response or opposition, with supporting evidence, to the Liquidation Motion and Order to Show Cause must be filed with the Court and served by mail or e-mail to Golden State's attorney Michael R. Weiss on or before January 14, 2011. The Conservator will file any replies, with supporting evidence, on or before January 21, 2011, and a copy of such reply will be served on the responding or objecting persons or entities and posted on the above noted website.

III. CONSERVATOR'S REDUCTION IN OPERATING EXPENSES AND CLOSING OF GOLDEN STATE'S OPERATIONS.

Pursuant to the Conservator's previous determination that the best course of action for Golden State's creditors is to further reduce operating expenses by permanently closing Golden

State's operations and terminating remaining employees, as of January 1, 2011, (1) all Golden
State employees have been terminated, (2) Golden State's home office lease was terminated and
Golden State vacated the premises, and (3) all of Golden State's district offices have been closed
and all leases have been terminated.

IV. ADMINISTRATION OF GOLDEN STATE'S RETAINED ASSETS AND LIABILITIES.

Assuming the Court grants the Conservator's Liquidation Motion and appoints the Commissioner as Golden State's liquidator, Golden State's remaining assets not transferred to IA American will be monetized by the Commissioner as Liquidator and its remaining liabilities will be subject to the claim priority and asset distribution procedures set forth in Insurance Code § 1011 *et seq.* Anyone having an interest in Golden State's assets may file a claim with the Liquidator in accordance with Insurance Code § 1021(a). Claimants will have until the Claims Bar Date, here December 31, 2011, to file a claim with the Liquidator. (Insurance Code § 1021(a).) The "particulars" of the claim must be set forth on "the form prescribed by the Commissioner", stating the statutory required content in accordance with Insurance Code § 1023. Claims not filed in the manner prescribed and within the time provided in Insurance Code § 1021 will "not be entitled to filing or allowance, and no action may be maintained thereon." (Insurance Code § 1024.)

If the Liquidator rejects a claim, the claimant may apply to the Court "for an order to show cause why the claim should not be allowed." (Insurance Code § 1032.) If the Liquidator accepts the claim, the claimant will be subject to the distribution priorities established in Insurance Code § 1033 and the requirement that claimants in the same class are entitled to share pro rata in distributions to the class. (Insurance Code § 1033; and *Commercial National Bank in Shreveport v. Superior Court* (1993) 14 Cal.App.4th 393, 398.)

V. <u>CONSERVATOR'S REQUEST FOR PROPOSALS CONCERNING GOLDEN</u> <u>STATE'S ARTWORK, REMOVABLE MURALS AND HISTORICAL RECORDS.</u>

Over the years Golden State accumulated a collection of art by African and African American artists, and accumulated a large amount of historical materials. Although a substantial

portion of the art collection was sold prior to conservation, Golden State's remaining art collection and historical materials include two removable murals on canvas, approximately 120 paintings, sculptures, photographs and mixed-media pieces, and numerous documents, photographs and recordings relating to Golden State and its history. An inventory of the art collection with photographs can be viewed at www.caclo.org/GoldenStateMutual/ArtCollection.

To monetize Golden State's artwork, murals and historical materials including the two removable murals, the Conservator has undertaken a Request for Proposals process in which persons and entities interested in purchasing Golden State's art and/or historical materials are required to submit proposals to the Conservator for such purchase or purchases. The Request for Proposals also can be viewed at www.caclo.org/GoldenStateMutual/ArtCollection. Due to continuing interest in the artwork, murals and historical materials, the Conservator continued the Request for Proposals process twice, most recently through October 29, 2010. At this time, the Conservator is evaluating the proposals received and intends to make recommendations to the Court in the next 30 to 60 days, accompanied by motions for approval of the recommended transactions. All sales of Golden State's artwork and historical materials having a market value of \$20,000 or more require the approval of this Court, and all such recommendations and proposals are contingent on this required approval.

The owner of the building at 1999 West Adams Blvd. in Los Angeles used for Golden State's home office claims ownership of the two removable murals on the grounds that the murals purportedly are fixtures and that the owner purportedly believed its 2009 purchase of the building included the purchase of the murals. The Conservator denies the claim because, among other reasons, the murals were expressly excluded from the sale of the building in 2005 prior to the owner's purchase of the building and the murals are not fixtures since they are removable.

VI. UPDATE ON LITIGATION INVOLVING GOLDEN STATE

There is only one remaining pending litigation matter against Golden State, which is James H. Nunya v. Golden State, Los Angeles Superior Court Case No. LAM 08M11746. Mr. Nunya is a former employee who unsuccessfully sought damages from Golden State in Los Angeles Small Claims Court, and appealed the denial of his claim to the Los Angeles Superior
