1 The Application of the California Insurance Commissioner, as Liquidator of CastlePoint
2 National Insurance Company ("Commissioner"), for an Order Authorizing Fourth Early Access
3 Distribution to State Insurance Guaranty Funds and Approving 2024 Financial Report, Financial
4 Statement, and Expenses Of Administration (collectively, "Application") was duly noticed and
5 set for hearing on November 6, 2025, at 9:00 a.m. in Department 301 before the Honorable
6 Christine Van Aken. No opposition or other response to the Commissioner's Application has
7 been filed with the Court. The Court, having duly considered the Application, including the
8 accompanying Memorandum of Points and Authorities and Declaration of Joseph Holloway
9 ("Declaration") and the exhibits thereto, as well as the absence of any filed opposition or other
10 response, and

11 GOOD CAUSE appearing therefor,

12 IT IS ORDERED that:

13 1. The Commissioner is hereby authorized to distribute a total of approximately
14 \$15,009,672 of the net assets of the CastlePoint estate to the state insurance guaranty funds or
15 similar entities as itemized in Exhibit A to the Holloway Declaration, provided that prior to any
16 such distribution, the state insurance guaranty fund in question has executed and delivered to the
17 Commissioner an agreement, substantially in the form set forth in Exhibit C to the Holloway
18 Declaration, to return the distributed assets as required to pay claims of secured creditors and
19 claims falling within the priorities established in Insurance Code section 1033, subdivisions (a)(1)
20 and (a)(2);

21 2. The Commissioner's 2024 financial report, Financial Statement, and expenses of
22 administration of the CastlePoint estate are hereby approved; and

23 3. The Commissioner is hereby authorized to take any and all actions necessary or
24 appropriate to carry out the within Order.
