23 The Verified Application for Order Approving Liquidator's Proposal to Disburse Assets  
24 to State Life and Health Insurance Guarantee Associations of the Insurance Commissioner of the  
25 State of California ("Liquidator"), in his capacity as Liquidator of SeeChange Health Insurance  
26 Company, was heard in Department 307 of the above-entitled court, on April 4, 2017, at 11:00  
27 a.m., the Honorable Maren Nelson, presiding. Having read and considered the Application, the

1 Memorandum of Points and Authorities submitted in support thereof and, argument having been  
2 heard and good cause appearing,

3 IT IS HEREBY ORDERED that:

- 4 1. The Application is granted;
- 5 2. The requirements of Insurance Code section 1035.5 have been satisfied;
- 6 3. The Liquidator's proposed early access distribution plan to disburse assets to state  
7 life and health insurance guarantee associations (collectively "LHIGAs") is approved;
- 8 4. The Early Access Agreement between the Liquidator and the National  
9 Organization of Life and Health Insurance Guaranty Associations, on behalf of its participating  
10 member state life and health insurance guaranty associations, attached as Exhibit A to the  
11 Application is approved;
- 12 5. The Liquidator is authorized to disburse \$5 million of the assets of SeeChange  
13 Health Insurance Company in Liquidation to the LHIGAs, subject to final adjustments of the  
14 disbursement amount;
- 15 6. The Liquidator is authorized to make further pro rata early access distributions in  
16 accordance with the early access distribution plan set forth in the Application, not earlier than  
17 thirty (30) days after the filing and service of his Notice of Proposed Early Access Distribution;  
18 and
- 19 7. The Liquidator is authorized to take any and all action necessary to accomplish the  
20 purposes of this Order and to carryout the Early Access Agreement.
