1 On July 6, 2016, in Department 86 of the Los Angeles Superior Court for the State of  
2 California, County of Los Angeles, located at 111 N. Hill Street, Los Angeles, California 90012,  
3 the Honorable Joanne O'Donnell, Judge Presiding (the "Court"), held the hearing on the  
4 Liquidator's Application For Orders Approving Liquidator's Determinations To Professionally  
5 Shred And Destroy Golden State's Remaining Records And Files ("Application"), filed by  
6 Applicant Insurance Commissioner of the State of California in his capacity as Liquidator  
7 ("Liquidator") of Golden State Mutual Life Insurance Company ("Golden State").

8 Michael R. Weiss appeared on behalf of the Liquidator. Other appearances, if any, are  
9 noted in the record.

10 The Court, having read and considered the Liquidator's Application, the Notice,  
11 Memorandum of Points and Authorities, Declarations of Scott Pearce and Michael R. Weiss, and  
12 evidence in support of the Application, and all documents and evidence submitted, and having  
13 heard and considered the arguments presented to the Court, and upon good cause shown,

14 IT IS HEREBY ORDERED that the Application is granted and that:

15 1. The Liquidator's determination to professionally shred and destroy Golden State's  
16 remaining records and files located at an off-site records storage facility, is approved;

17 2. The Liquidator's determination that the approximate cost of \$54,796.02 to  
18 professional shred and destroy Golden State's remaining records and files is a reasonable and  
19 necessary expense incurred for Golden State, is approved; and

20 3. The Liquidator is authorized to take any and all actions necessary to accomplish the  
21 purposes of the above requested Orders.
