1 The Court GRANTS the motion. The Insurance Commissioner may make the
2 distributions to the remaining creditors of Enterprise Insurance Company Trust to the extent and
3 as set forth in the motion. The Insurance Commissioner as Trustee may retain the closing budget
4 set forth in the declaration accompanying the motion; any unexpended portion of this budget
5 shall be distributed upon closing of the trust to the remaining creditors of Enterprise Insurance
6 Company Trust. Should any further assets be owed to or collected by Enterprise Insurance
7 Company Trust, they are deemed and are hereby assigned to Mission Insurance Company Trust,
8 but must be distributed by Mission Insurance Company Trust to the affiliate creditors of
9 Enterprise Insurance Company Trust according to their respective percentages of entitlement.
10 The Insurance Commissioner as Trustee shall make the distributions and file a declaration within
11 120 days that the distributions are completed.
