21 I, David Wilson, hereby declare under penalty of perjury of the laws of the State of  
22 California as follows:

23 1. I am over eighteen years, and I am competent to be a witness.

24 2. I am the Chief Executive Officer ("CEO") and Special Deputy Insurance Commissioner  
25 of the Conservation & Liquidation Office ("CLO") of the California Department of  
26 Insurance ("CDI") and have held this position since 2005, when I was appointed as CEO of the  
27 CLO by the California Insurance Commissioner and confirmed by the California State Senate. I  
28 am the Court-appointed Deputy Conservator of Majestic. In the foregoing capacities I am

1 knowledgeable about the financial affairs of Majestic. The following facts are known by me to be  
2 true and correct and of my own personal knowledge, except to those which I have expressed as  
3 being based upon my information and belief, and if called upon to testify thereto I would and  
4 could competently do so.

5 3. The statements contained in this declaration are not all within my personal knowledge,  
6 and I am informed that no single officer of the CLO has personal knowledge of all of these  
7 matters. The statements in this declaration are based upon information assembled by authorized  
8 employees of the CLO, and I am informed and believe that the statements based upon that  
9 information are true. As to those matters that are within my own personal knowledge, the  
10 statements are true. If called upon as a witness, I would testify as set forth herein.

11 4. On November 5, 2015, this Court entered the Order Approving Application of the  
12 Insurance Commissioner, as Conservator of Majestic Insurance Company, For Payment of  
13 Conservator Expenses and Final Distribution of Assets (hereinafter "Order").

14 5. Paragraph 6 of said Order provides that the estate of Majestic Insurance Company shall  
15 be closed and the Commissioner discharged as Conservator upon the filing of a declaration that  
16 the Commissioner has distributed assets in accordance with this Court's Order approving final  
17 distribution.

18 6. In accordance with the Court's Order, the Commissioner distributed a total of  
19 \$3,100,000.00 to Embarcadero Liquidating Trust which they received.

20 7. Pursuant to this Court's Order, the Commissioner retained \$403,421.00 for payment of  
21 administrative expenses incurred by the Commissioner for administrative and closing costs.


