1       The Court after reviewing the Application for Order Approving Liquidator's Proposal to  
2 Disburse Assets to Certain State Insurance Guarantee Associations ("Application") and the  
3 Declarations submitted in support thereof, all of which were filed in Department 322-CCW of the  
4 above-entitled Court and served on all parties, and the associations in and the commissioners of  
5 insurance of each of the states by certified United States First Class Mail on or before July 27,  
6 2012, and the last day to file and to serve an objection or opposition to said Application having  
7 been August 27, 2012, and no objection or application having been filed as of that date;

8       IT IS HEREBY ORDERED that:

- 9       1.     The requirements of Insurance Code section 1035.5 have been satisfied;
- 10       2.     The Court approves the proposal of the Liquidator of California Compensation  
11 Insurance Company to distribute and pay a total of \$34,680,371 from the assets of California  
12 Compensation Insurance Company to certain insurance guarantee associations as set forth in the  
13 Application;
- 14       3.     The Court approves the proposal of the Liquidator of Combined Benefits  
15 Insurance Company to distribute and pay a total of \$572,602 from the assets of Combined  
16 Benefits Insurance Company to certain insurance guarantee associations as set forth in the  
17 Application;
- 18       4.     The Court approves the proposal of the Liquidator of Superior National Insurance  
19 Company to distribute and pay a total of \$3,293,891 from the assets of Superior National  
20 Insurance Company to certain insurance guaranty associations as set forth in the Application;
- 21       5.     The Court approves the proposal of the Liquidator of Superior Pacific Casualty  
22 Company to distribute and pay a total of \$1,873,621 from the assets of Superior Pacific Casualty  
23 Company to certain insurance guarantee associations as set forth in the Application;
- 24       6.     The Court approves the proposal of the Liquidator of Commercial Compensation  
25 Casualty Company to distribute and pay a total of \$348,601 from the assets of Commercial  
26 Compensation Casualty Company to certain insurance guarantee associations as set forth in the  
27 Application; and
