1 The Insurance Commissioner’s *Application for Order Approving Financial Report and*
2 *Expenses of Administration* and *Supplement to Application for Order Approving Financial Report*
3 *and Expenses of Administration* (collectively, “Application”) was scheduled for hearing on
4 December 30, 2021 in Department 302 before the Honorable Ethan P. Schulman. No opposition
5 or other response to the Commissioner’s Application has been filed with the Court. The Court,
6 having duly considered the Application and supporting documents, including the accompanying
7 Memorandum of Points and Authorities and Declaration of Joseph Holloway (“Declaration”) and

- 16 2. The Commissioner’s expenses paid in the administration of the estate of
17 CastlePoint National Insurance Company during the 2020 calendar year, as
18 described in the Application and supporting documents, are hereby approved and
19 ratified.
- 20 3. All persons, including non-parties are reminded and warned that, absent further
21 order of the Court, they are enjoined under the Liquidation Order, *inter alia*, from
22 “instituting, prosecuting or maintaining any action at law or suit in equity
23 (including without limitation actions or proceedings to compel discovery or
24 production of documents or testimony...” against the CastlePoint estate, the
