1 On August 19, 2019, at 9:30 a.m. in Department 302, the Court heard the amended motion
2 of applicant Insurance Commissioner of the State of California, as the liquidator of Western
3 Employers Insurance Company, for approval of a second interim distribution to policyholder-
4 class claimants (Class 2) and general creditors (Class 7) who have approved claims that were
5 resolved by June 30, 2019, as set forth in the motion. The motion was not opposed. The Court
