24 PLEASE TAKE NOTICE that on November 19, 2015 at 9:30 a.m. or as soon thereafter as  
25 the matter may be heard in Department 302 of the Superior Court of California for the City and  
26 County of San Francisco, California, the Insurance Commissioner of the State of California  
27 ("Commissioner), in his capacity as Conservator and Liquidator of HIH America Compensation  
28 & Liability Insurance Company ("HIH America") will and hereby does apply to the Court for an

1 Order (1) approving the final distribution of the estate assets of HIH America; (2) approving  
2 payment of the Commissioner's expenses for the period of July 1, 2014 through May 31, 2015 in  
3 the amount of \$306,812; (3) approving the Commissioner's reserve closing budget; and (4)  
4 closing the HIH America estate and discharging the Commissioner as Conservator and  
5 Liquidator.

6 The application is made pursuant to Insurance Code sections 1033, 1035, 1036 and 1037,  
7 which authorize the Commissioner to pay expenses incurred in the administration of insolvent  
8 insurers pursuant to court approval, and to distribute assets. The application will be based on this  
9 notice of application, the application and the memorandum of points and authorities filed in  
10 support thereof, the declarations of John Battle and Raymond Minehan filed in support thereof,  
11 the files and pleadings in this case, and such oral argument as may be made in support of the  
12 application at the hearing on this matter.
