2 and GOOD CAUSE APPEARING, THE COURT MAKES THE FOLLOWING ORDER:

3 1. The Report and Account of Liquidator for the period January 28, 1985 to December
4 31, 2006 is settled and approved;

5 2. The Commissioner is authorized to reserve the appropriate funds for closing this
6 estate and is authorized to maintain all records of S&H for three years from the date of this order
7 and thereafter is authorized to destroy all records of S&H except for those records necessary for
8 examination by the Department of Finance or other auditor of the Commissioner's books and
9 records pursuant to Insurance Code section 1061;

10 3. Upon this Court's order, the Commissioner, as Conservator and Liquidator, is
11 discharged from his duties and from any liability in any capacity to any person arising, occurring
12 or relating to his activities prior to, or during, his conservation and liquidation of S&H;

13 4. The estate of S&H is closed and this action is closed and no further action is
14 required of the Commissioner; and

15 5. The Commissioner is authorized to take any action necessary to accomplish the
16 purposes of this Order.
