On April 12, 2023, the Honorable Susan L. Greenberg held a Status Conference in chambers with counsel for Petitioner the Insurance Commissioner of the State of California as Conservator ("Conservator") of California Insurance Company ("CIC") and counsel for Respondent CIC ("Respondent"). Counsel present for the Conservator were Michael J. Strumwasser, Cynthia Larsen and Justin Giovannettone. Counsel present for Respondent were Shand S. Stephens, Tony Coles and Jeanette Barzelay. Also present on Zoom was counsel for CIC policyholder Environmental Control, Phil Neal Walker. Following discussions at the Status Conference concerning the scheduling and conduct of the hearing on the Conservator's pending Application for Approval of Rehabilitation Plan ("Plan Approval Application") and as a result thereof, IT IS HEREBY ORDERED:

- 1. The August 3, 2023 hearing on the Conservator's Plan Approval Application is vacated and rescheduled as set forth below.
 - 2. On July 25, 2023, at 9:00 a.m., in Courtroom 2B, Department 3, San Mateo Superior Courthouse, Southern Court, 400 County Center, Redwood City, CA 94063, the Court will commence the hearing on the Plan Approval Application, during which counsel for the Conservator and Respondent will each be permitted 30 minutes to present arguments regarding the Plan Approval Application and respond to questions posed by the Court before or at the hearing.
 - 3. The hearing on the Plan Application will resume on August 7, 2023, at 2:00 p.m., in Courtroom 2B, Department 3, San Mateo Superior Courthouse, Southern Court, 400 County Center, Redwood City, CA 94063.
 - a. The Court will post its tentative ruling on the Plan Approval Application by 3:00 p.m. on August 4, 2023.
 - b. At the August 7, 2023 hearing, counsel for the Conservator and Respondent will each be permitted up to 75 minutes to make their respective arguments and respond to the Court's questions.
