1 On May 22, 2012, in Department 86 of the Los Angeles Superior Court for the State of
2 California, County of Los Angeles, located at 111 N. Hill Street, Los Angeles, California 90012,
3 the Honorable Ann I. Jones, Judge Presiding (the "Court"), held the hearing on the Application
4 To Approve Conservation And Liquidation Expenses ("Application"), filed by Applicant
5 Insurance Commissioner of the State of California in his capacity as Liquidator ("Liquidator") of
6 Golden State Mutual Life Insurance Company ("Golden State").

7 Attorney Michael R. Weiss appeared on behalf of the Liquidator. Other appearances, if
8 any, are noted in the record.

9 The Court, having read and considered the Liquidator's Application, the Notice,
10 Memorandum of Points and Authorities, Declarations of Scott Pearce and Michael R. Weiss, and
11 evidence in support of the Application, and all documents and evidence submitted, and having
12 heard and considered the arguments presented to the Court, and upon good cause shown,

13 IT IS HEREBY ORDERED that the Application is granted and that:

- 15 from September 30, 2009 through December 31, 2011 are approved; and
