The verified Application of the Insurance Commissioner of the State of California, having been filed herein and it appearing to the Court from said Application that respondent herein is in such condition that it is insolvent within the meaning of the Insurance Code and that its further transaction of business will be hazardous to its policyholders, its creditors, and to the public,

## IT IS HEREBY ORDERED:

1. That the Insurance Commissioner of the State 27 of California, applicant herein, is hereby appointed

1 Conservator of Signal Insurance Company, respondent herein, and is 2 directed as such Conservator to conduct the business of respondent 3 or so much thereof as to the applicant may seem appropriate; and 4 applicant is authorized as such Conservator in his discretion to 5 pay or defer payment of all proper claims and of obligations 6 against respondent accruing prior to or subsequent to his appointment as Conservator:

- 2. That said Conservator forthwith take possession of 9 all of respondent's assets, books, records and property, both real and personal, wheresoever situated:
- 3. That there is hereby vested in said Conservator and 12 his successors in office title to all of the property and assets 13 of said respondent, and all persons are enjoined from interfering 14 with said Conservator's possession and title thereto;
- 4. That said respondent, its officers, directors and 18 agents and employees are hereby enjoined from transacting any of 17 the business of respondent, and from disposing of any of respond-18 ent's property or assets until further order of this court;
- 5. That all persons are enjoined from instituting or 20 maintaining any action at law or suit in equity including but not 21 limited to matters in arbitration, against said respondent or against said Conservator of said respondent, and from attaching or executing upon or taking any legal proceeding against any of the property of respondent, and from doing any act interfering with the 25 conduct of said business by the conservator, except after an order from this Court obtained after reasonable notice to the conservator, the property full protection of the conservator, agents and employees

- 7. That all funds in bank accounts in the name of 4 respondent in various banks in the State of California, and in 5 other banks wheresoever situated are hereby vested in the 6 conservator and subject to withdrawal upon his order only;
- 8. That any and all agents of respondent and all 8 brokers who have done business for respondent make all remittances 9 of funds collected by them or in their hands directly to the 10 applicant as conservator;
- 9. That the conservator is authorized to pay all 12 reasonable costs of operating respondent as conservator out of the 13 funds and assets of said respondent;
- 10. That all persons having possession of any lists of 15 policyholders of respondent deliver all such lists to the 16 conservator; that all persons are enjoined from using any of such 17 lists or any information contained therein without the consent of said conservator;
  - 11. That the conservator is authorized to initiate such legal or equitable actions in this or other states as he may deem necessary to carry out his duties as conservator of respondent. Signal Insurance Company.
