The statements in this declaration are based upon information assembled by authorized employees of the CLO, and I am informed and believe that the statements based upon that information are true. As to those matters that are within my own personal knowledge, the statements are true. If called upon as a witness, I would testify as set forth herein.
- 4. On November 5, 2015, this Court entered the Order Approving Application of the Insurance Commissioner, as Conservator of Majestic Insurance Company, For Payment of Conservator Expenses and Final Distribution of Assets (hereinafter "Order").
- 5. Paragraph 6 of said Order provides that the estate of Majestic Insurance Company shall be closed and the Commissioner discharged as Conservator upon the filing of a declaration that the Commissioner has distributed assets in accordance with this Court's Order approving final distribution.
- 6. In accordance with the Court's Order, the Commissioner distributed a total of \$3,100,000.00 to Embarcadero Liquidating Trust which they received.
- 7. Pursuant to this Court's Order, the Commissioner retained \$403,421.00 for payment of administrative expenses incurred by the Commissioner for administrative and closing costs.

8. The Commissioner has taken all necessary steps pursuant to the terms of this Court's Order, and will close the estate concurrent with the filing of this declaration.
