- 1. A Court Order authorizing the Commissioner to sell the real property, owned by Golden State, located at 1244 Solano Avenue in City of Vallejo, County of Solano, California [APN 0059-012-060] (the "Property"), to Gerald Hinton ("Hinton"), pursuant to the terms of a Real Estate Purchase Agreement and its First Amendment between the Commissioner and Hinton (collectively, "Purchase Agreement"); and
- 2. A Court Order authorizing the Commissioner to take any and all actions necessary to accomplish the purposes of the above requested Order.

## **Grounds for the Application**

This application is made pursuant to Insurance Code § 1037 and the Order of Liquidation for Golden State on the grounds that the sale of the Property to Hinton is within the Commissioner's discretion, is geared towards maximizing Golden State's liquidation estate value and is in the best interests of Golden State's creditors, because: (1) The sale price of \$63,625 is the reasonable fair market value for the Property; (2) Hinton is a third party purchaser not related to the Commissioner or to any person involved in Golden State's liquidation; (3) The Property was used for Golden State's district office in Vallejo, California and has been listed for sale for nearly three years since October 15, 2010; (4) The sale of the Property stops the further expenditure of Golden State's limited assets on property maintenance expenses including

maintenance, insurance, property taxes and other costs associated with ownership and maintenance of the Property; and (5) The sale is consistent with the Commissioner's duty to marshal and monetize Golden State's remaining assets for distribution to creditors, and is consistent with the Commissioner's authority and discretion under the Court's Order of Liquidation, the Insurance Code and case law.

Accordingly, Court approval for the sale of the Property to Hinton is appropriate.
